



# Mental Health Services Act Community Planning Meetings

Beginning in April 2012, a series of community forums will be held to gather public input into the development, modification and implementation of mental health programs in the County of San Bernardino.

The Mental Health Services Act (MHSA) Proposition 63, was passed by California voters in November 2004 and went into effect in January, 2005. The Act is funded by a 1% surcharge on personal income over \$1 million per year.

The intent of the funding is to reduce the long-term adverse impact on individuals, families and state and local budgets resulting from untreated serious mental illness.

The Prevention and Early Intervention component of the MHSA provides funding for a variety of programs that promote and assist individual wellness. Community members participation will provide input into the expansion and/or creation of programs that will directly benefit communities within the county.
